## \$1,000 WEEKLY CASH PRIZE GIVEAWAY!

### The Rules:

Download nēdl, sign up and share your profile page. When people click the link and tap the button "Notify Me" or download the app and Favorite your profile, they will be notified anytime you go live. Everytime your profile is "Favorited" or the "Notify Me" button on your share page is tapped, you will receive a new follower. The user with the most new followers each week wins.

### CONTEST RULES

#### NO PURCHASE IS NECESSARY TO ENTER OR WIN.

- 1. Eligibility:** This Campaign is open only to those who sign up on nēdl and nēdlcast and who are 13 years of age as of the date of entry. Employees of nēdl, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.
- 2. Agreement to Rules:** By participating, the Contestant ("You") agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of nēdl as final and binding as it relates to the content of this Campaign.
- 3. Campaign Period:** We will be keeping track of how many new people follow your nēdlcasts each week starting September 1, 2019 5:00pm, Pacific Time and ending September 30, 2019, 11:59pm, Pacific Time.
- 4. How to Enter:** You are entered into the campaign once you simply download the nēdl app in the App Store or Google Play and sign up. You then start your own nēdlcast by tapping the microphone button at the bottom of the screen and share with your friends so that they may follow your nēdlcast account - even if you never go live.
- 5. Cash prize:** The Winner of the Campaign (the "Winner") will receive One Thousand Dollars (\$1,000) USD cash prize. The specifics of the cash prize delivery shall be solely determined by nēdl. No other cash prize or prize substitution shall be permitted except at nēdl's discretion. The cash prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of the cash prize or transfer/assignment of the cash prize to others by Winner is permitted. otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 5 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected.
